APPLICATION INFORMATION and INSTRUCTION SHEET

Please read before filling out pages 1-3 of the application.

Each person who meets the criteria for membership and desires to become a member must complete the AFTC Application form and agree to sign the Code of Ethics. All applicants must be approved by the Board of Governors, in compliance with the Constitution and By-Laws of the Club. All fees and dues must be submitted with the application. Fees and dues for all categories are set by the Board of Governors.

Individual Member: One (1) adult, eighteen (18) years of age or older. An individual member shall receive one (1) copy of club mailings such as, The Annual Book and announcements and have one (1) votes.

Dual Member: Two (2) adults, eighteen (18) years of age or older, residing at the same address. A dual membership shall receive one (1) copy of club mailings such as, The Annual Book and announcements and will have one (2) votes.

Junior Member: One (1) individual at least nine (9) years of age and under (18) years of age. Use the "Junior Application".

ANNUAL JUNIOR MEMBERSHIP DUES \$15.00

DUES PAID BETWEEN OCTOBER 1 AND DECEMBER 31 WILL PAY FOR THE FOLLOWING YEAR AS WELL

DUES PAID BETWEEN JULY 1 AND SEPTEMBER 30 ARE HALF DUES PLUS FULL INITIATION FEES AND ARE FOR THE CURRENT YEAR ONLY

Please note that the dues amount is determined by the month when you apply.

Applications must include signatures of the two sponsors.

Membership Categories

INDIVIDUAL – One (1) adult member, eighteen (18) years of age or older. An individual member enjoys all club privileges including the right to vote and hold office. Individual members shall receive one (1) copy of club mailings such as The Annual Yearbook and announcements and have one (1) vote.

HOUSEHOLD – Two (2) adult members residing in the same household, each eligible to vote and hold office. Household members shall receive one (1) copy of club mailings such as The Annual Yearbook and announcements and have (2) votes.

FOREIGN – Individual or Household members who are not a resident of the United States, or its territories and possessions. Foreign members shall be entitled to all club privileges except voting and holding office. Foreign members shall receive one (1) copy of club mailings such as The Annual Yearbook and announcements.

JUNIOR – Open to children under 18 years of age; a non-voting, non-office holding membership which automatically converts to regular membership at age 18. Junior members shall receive (1) copy of club mailings such as The Annual Yearbook and announcements.

HONORARY – An individual who has made a significant contribution to the Sport, Breed, or the Club; Honorary members are selected by the Board, pay no dues, do not vote, or hold any elected office or appointed position. Honorary members shall receive one (1) copy of club mailings such as The Annual Yearbook and announcements.

LIFE – Those individuals who attain fifty (50) years of membership, cumulatively or continuously, pay no dues, and are eligible to vote and hold office. Life members shall receive one (1) copy of club mailings such as The Annual Yearbook and announcements.
